

Covering key spheres — economy, politics and governance, education, leadership, and artificial intelligence — these programs emphasize not only empirical knowledge, theoretical foundations, and strategic policy skills, but also core principles such as the right to education, equity, and inclusion, equipping students to navigate and shape an increasingly complex world.

Each PgD program offers a focused academic and practical experience:

- **PgD in Economic Policy**: This program addresses the structural challenges of modern economic systems, offering a strong foundation in development studies, macroeconomics, microeconomics, public finance, and international trade, with a special focus on Sri Lanka's economic realities. It also builds critical research skills essential for policy development.
- **PgD in Education Policy**: This program explores Sri Lanka's education landscape across primary, secondary, and tertiary levels, examining access disparities, governance challenges, curriculum development, teacher training, and the broader impacts of globalization. It emphasizes building equitable, inclusive, and resilient education systems to support national development.
- **PgD in Strategic Leadership**: Preparing future-focused leaders, this course develops skills in visionary thinking, emotional intelligence, ESG and DEI principles, innovation, and strategic planning. It offers practical insights into navigating Sri Lanka's regional and global position within a multipolar world
- **PgD in Politics and Governance**: Offering a comprehensive understanding of political thought, governance structures, and policy-making, this course critically analyzes Sri Lanka's postcolonial political evolution alongside global shifts in international relations, fostering strong analytical and leadership capabilities.
- **PgD in Cybersecurity Policy** : Addressing the rapid technological changes and their societal impacts, this program focuses on cybersecurity principles, 4IR technologies, risk management, AI governance, and the protection of national infrastructure, preparing students for strategic roles in safeguarding digital and national security.

Through these programs, BALPP aims to cultivate a new generation of scholars and professionals capable of contributing innovative, ethical, and strategic solutions to the national and global challenges of the 21st century.

COMMON MODULE

Introduction to the Common Module

All students enrolled in the Postgraduate Diploma (PgD) programs will begin their studies with a shared core module titled **Essential Skills in Strategic Leadership**, which lays the foundation for effective leadership across sectors. This interactive, student-centered course focuses on building critical competencies such as **strategic thinking**, **ethical decision-making**, **persuasive communication**, **conflict resolution**, and **team leadership**. The module is designed to cultivate a confident leadership mindset and prepare students for success in their specialized postgraduate studies and professional environments.

In the second semester, all students will also participate in a **common session on Research Methodology, Academic Writing, and Capstone Project development**. This session equips students with essential research and analytical skills—covering both qualitative and quantitative methods—while emphasizing ethical practices and strong academic writing. Through structured guidance on topic selection, project planning, and the use of analytical frameworks, students are supported in producing original, rigorous, and policy-relevant Capstone Projects that translate theory into real-world impact.

Our overall academic approach emphasises:

- Interactive, real-world learning through case studies, simulations, and collaborative projects that mirror the complexities faced by leaders today
- Comparative perspectives by drawing from global best practices, enabling students to contextualize Sri Lankan challenges within international frameworks
- Engagement with expert faculty and international guest speakers, bringing diverse experiences and insights directly into the classroom
- Flexible learning options, including hybrid delivery formats to accommodate the needs of working professionals and adult learners
- A strong focus on ethical leadership, strategic communication, critical policy analysis, and innovation
- These Postgraduate Diplomas are ideally suited for individuals who aspire to drive positive change across the public, private, and civil society sectors, combining advanced academic training with practical skills to address contemporary challenges with confidence and vision.

Common Module - Essential Skills in Leadership

Four distinct themes for a module on Essential Skills in Leadership, each designed to be delivered in a two-hour session by different lecturers:

1. Strategic Thinking and Decision-Making

Focus: Equipping leaders with essential tools and frameworks to make informed, ethical decisions under pressure. The module introduces core concepts such as SWOT analysis, systems thinking, and risk assessment to help participants analyze challenges holistically and identify strategic responses.

Key skills include prioritizing tasks using the urgency-importance matrix, evaluating risks, and balancing short-term demands with long-term goals. Together, these tools foster a structured, ethical, and forward-thinking approach to leadership and problem-solving.

2. Effective Communication and Influence

Focus: Explores how leaders can inspire, persuade, and build trust through clear, emotionally intelligent communication. The module aims to strengthen a leader's ability to listen actively, frame messages persuasively, and adapt to different communication styles while maintaining clarity and authenticity.

Key concepts include storytelling for engagement, emotional intelligence for empathy and impact, and techniques for navigating various communication preferences. Interactive elements such as role-plays and speech simulations allow participants to practice giving feedback, resolving conflict, and motivating teams, while receiving constructive feedback on their delivery and influence.

3. Conflict Resolution and Negotiation

Focus: Equips participants with practical strategies to manage interpersonal and organizational conflicts constructively. The module focuses on understanding conflict styles, applying negotiation techniques such as win-win and principled negotiation, and navigating power dynamics to reach effective outcomes.

Interactive exercises include mock negotiations and role-plays where participants assume roles in realistic conflict or negotiation scenarios, followed by group debriefs. These activities help students apply mediation skills, analyze conflict behaviors, and reflect on effective approaches to resolving disputes and reaching consensus.

4. Building and Leading High-Performing Teams

Focus: Focuses on developing the leadership skills necessary to cultivate collaboration, accountability, and a shared sense of purpose within teams. Participants will explore key concepts such as team development stages, motivation techniques, effective delegation, inclusive leadership, and constructive performance feedback.

Through interactive team-building activities and case simulations, students will apply these concepts in practical settings, addressing challenges related to team dynamics, goal-setting, and performance management. Group debriefs will encourage reflection on leadership strategies for sustaining high-performing, inclusive teams.



POSTGRADUATE DIPLOMA IN POLITICS & GOVERNANCE

The Postgraduate Diploma in Politics and Governance offers a broad and rigorous foundation in Political Science, combining classical theory with contemporary practice. Students will trace the evolution of political thought from ancient Greece through the Enlightenment to modern debates, critically engaging with key themes, thinkers, and global political issues.

The program provides an in-depth exploration of public policy processes and governance dynamics, examining the roles of political, administrative, and institutional actors within democratic frameworks. A special emphasis is placed on Sri Lanka's political and constitutional development, studying major transformations, governance challenges, ethnic politics, and electoral reforms. At the international level, students will explore post-Cold War global politics, including the rise of a multipolar world, the influence of non-state actors, technological change, and new models of global governance.

Through a blend of theory, comparative perspectives, and real-world analysis, the course equips students with critical analytical skills necessary to understand and engage with the complexities of both Sri Lankan and international political landscapes.



POSTGRADUATE DIPLOMA IN EDUCATION POLICY

Students will examine key policies underpinning free university education in Sri Lanka, analyzing their effects on gender, ethnic, and socioeconomic disparities. The course also delves into the political movements and social unrest arising from education inequities, encouraging students to engage with policy reforms aimed at improving access, quality, and the realization of the right to education for all.

Through international comparisons and Sri Lankan case studies, participants will explore how governments regulate private education, the challenges of aligning higher education with labor market needs, and the impact of neo-liberal corporatization trends that increasingly frame students as 'clients.' This program equips students with the critical tools to understand, evaluate, and influence education policy for more equitable, inclusive, and responsive system
